This Implementation Agreement is entered into force on 21/11/2024 by and between:

- **I. Dr. Henry Praherdhiono, S.Si, M.Pd**, Head of Department of Educational Technology, Faculty of Education, who therefore legally represents and acts for and on behalf of the Faculty of Education, State University of Malang, located at Jalan Semarang 5, Malang, here in after referred to as Party I.
- II. Prof. Ho Wing Kei Keith, Head of Department of Science and Environmental Studies, The Education University of Hong Kong, who therefore legally represents and acts for and on behalf of The Education University of Hong Kong, Hong Kong, 10 Lo Ping Road, Tai Po, New Territories, Hong Kong, here in after referred to as Party II.

PARTY I and **PARTY II** hereinafter referred to collectively as **THE PARTIES**. The Parties hereby agree to jointly arrange an Implementation Agreement on the Staff Exchange and Collaboration Research by **THE PARTIES** as regulated in the following articles.

Article 1 PURPOSE AND OBJECTIVES

- (1) The purpose of this Implementation Agreement is to serve as the basis for the Implementation Agreement arranged by **THE PARTIES** in accordance with the scope of this Implementation Agreement Regulation.
- (2) The objective of this Implementation Agreement is to support the activities of **THE PARTIES** in relation to cooperations regarding the Research Staff Exchange and Collaboration.

Article 2 SCOPE OF ACTIVITIES

- (1) Both parties agree to collaborate in research staff exchange
- (2) Public Seminar: Share of frontier research related the Educational Technology, delivered by Ence Surahman, Ph.D.
- (3) Campus Visit: Tour our laboratories, library, and other facilities.
- (4) Knowledge Sharing Session: Interact with our colleagues and the Project Team(s) in SES.

Article 3 FUNDING

The amount of funds for this activity is agreed upon by both **PARTIES** and charged to each **PARTY**, which comes from a mutual agreement by the provisions during program implementation.

Article 4 DURATION

- (1) This staff exchange and collaboration program held from November 20th to November 22nd, 2024 as agreed by both parties.
- (2) The **FIRST PARTY** and the **SECOND PARTY** may renew or extend the cooperation agreement by mutual consent.

Article 5 ACTIVITY IMPLEMENTATION

(1) The implementation of the activity in question according to the agreement of the PARTIES is carried out for 3 days in the agreed unit / field and location.
