This Memorandum of Understanding is made and signed on Wednesday, 3<sup>rd</sup> of April, 2024 between two parties, as followed:

2. Prof.Dr. Andoko, S.T., M.T

Dean of Faculty of Engineering, representing Universitas Negeri Malang having its address at Jalan Semarang No. 5 Indonesia, hereinafter referred to as SECOND PARTY.

## ARTICLE 1 OBJECTIVES

## ARTICLE 3 REALIZATION OF MEMORANDUM OF UNDERSTANDING

Any matters related to the follow up of this Memorandum of Understanding will be regulated and set in a separate Letter of Agreement which will be performed by an officer duly assigned by PARTIES and constituted an integral part of this Memorandum of Understanding.

## ARTICLE 4 DURATION

This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of **Three (3) years** and this Memorandum of Understanding may be extended for a further period or terminated prior to expiry date by mutual agreement of PARTIES.



## **ARTICLE 5 NO AGENCIES**

Nothing contained in this Memorandum of Understanding implies that any agency, cooperation, or joint ventures between two parties that have been established, and it is well understood that the PARTIES will carry out activities under this MoU as an independent institution. No institution has the right or authority to create obligations or responsibilities by name, or on behalf of, any other party.

#### ADDENDUM FOR INTERNATIONAL RESEARCH AND OBSERVATION PROGRAM

### 1. GENERAL

- 1.1 The program will be for a period of four (4) weeks including travelling days to and from Malaysia.
- 1.2 The host is given a provision to conduct selection process as agreed upon by both parties.
- 1.3 For the program to be effective each training day will be for a period of eight (8) hours, which may be extended beyond the specific hours as and when the needs arise with compensation.
- 1.4 The Program will be scheduled for SIX (6) days with ONE (1) rest day in a week and the host, at its sole discretion, shall determine the schedule.
- 1.5 During the duration of exchange program, the host will provide the Students with the followings:
  - a. Allowance of RM 500.00 for the duration of the program.
  - b. Rent free accommodation.
  - Minimum three (3) meals daily.
  - d. Transportation to and from the place of training shall be provided should it be required.

### 2. HOST UNDERTAKINGS

- 2.1 The host will provide transportation for the Students from the point of entry in the host country, to its premise and vice versa for their departure upon completion of the program.
- 2.2 The host will issue testimonial and certificate to those Students who successfully completed the program.

### 3. HOME COLLEGE UNDERTAKING

3.1 The home college will be responsible to inform the Students of their responsibility for travel document, transportation and other related cost from home country to the point of entry to the host country and vice versa upon completion of the exchange program.

### 4. STUDENT UNDERTAKINGS

- 4.1 To devote their efforts and attention in diligently performing the duties as scheduled.
- 4.2 To observe and comply with all the rules, regulations and standing orders as may be in force from time to time governing the conduct and discipline.
- 4.3 To adhere to all work procedures and rules of the assigned sections/departments.
- 4.4 Not to indulge or involve in any unlawful, criminal, political, immoral, drug or gambling activities.
- 4.5 Refrain from divulging any of host's confidential information.
- 4.6 Repatriation cost in case of any breach of the abovementioned conditions is the responsibility of the student.
